

## **BAB III**

### **PENUTUP**

#### **A. Simpulan**

1. UNRWA merupakan organisasi yang vital bagi pengungsi Palestina yang ada di Jalur Gaza. UNRWA membantu para pengungsi Palestina yang ada di Jalur Gaza dengan memberikan bantuan langsung berupa akses pendidikan, kesehatan, layanan sosial, proteksi, keuangan mikro, serta infrastruktur kamp sebagai bentuk pemenuhan hak asasi bagi para pengungsi.
2. Di samping itu, dalam menjalankan mandat PBB tersebut, UNRWA menghadapi berbagai macam kendala seperti; susahnya akses bantuan ke Jalur Gaza karena adanya blokade yang dilakukan oleh Israel, serta terjadi penangguhan dana oleh donatur yang berdampak pada kas UNRWA itu sendiri. Dengan demikian, keberadaan UNRWA ini sangat dibutuhkan oleh pengungsi Palestina yang berada di Jalur Gaza karena hak-hak yang dimiliki oleh para pengungsi dipenuhi oleh UNRWA.

#### **B. Saran**

Agar kegiatan yang dijalankan oleh UNRWA dapat berjalan dengan baik, perlu adanya dukungan dari negara-negara lain maupun kerja sama dari organisasi-organisasi internasional lainnya. Selanjutnya, seharusnya PBB dapat bertindak lebih tegas terhadap blokade kemanusiaan yang dilakukan oleh Israel

dan mengeluarkan resolusi untuk segera menghentikan kependudukannya di Palestina. Selain itu, negara-negara lain, terutama negara donor, diharapkan dapat tetap memberikan bantuan keuangan kepada UNRWA atas dasar prinsip kemanusiaan dan keadilan.
